All the faculty member of all the departments prepare their notes well in advance before their lectures. All the departments are equipped with LCD projectors, computers, library to provide enough study material to the students. The students are assessed with the help of regular internal exams before their semester exams. All the records of the internal exams, students records are well documented. The students are continuously assessed through assignments, classroom performance and internal assessment exams. The tests and assignments are mapped with the course outcomes. Feedback and monitoring on the curriculum is carried out through a wide variety of mechanisms like meeting of the class representatives with HOD's of the concerned departments, director, offline feedback form and monthly reports of the faculty. The faculty share the content with the students in all the possible document and multimedia formats. Remedial classes and personality development classes, departmental seminars, lectures by experts, visiting faculties, field trips, industrial visits, laboratory and project work are exercised regularly for students enrichment. The Institution constantly strives to upgrade the infrastructural facility like LCD projectors, internet access in the classes, extensive use of ICT by the teachers and regular monitoring and feedback mechanisms.

The requirement is kept before the management committee. Any new facility constructed/ acquired is provided by the management before the commencement of the semester. The physical facilities including laboratories, classrooms and computers etc. are made available for the students who are admitted in the college. The buildings are maintained for their upkeep and repairs on a regular basis. Right from its inception the college has been improving its infrastructure to meet its ever increasing growth. Additional blocks for academic and administrative purposes have been constructed. Floors have been added to the existing blocks to enhance the facilities. Renovation of older blocks and modernization of laboratories have been done to meet the ever changing academic requirements.
